## SECTION 1: INTRODUCTION

In accordance with the California Environmental Quality Act (CEQA) Guidelines Section 15088, the City of San Ramon, as the lead agency, has evaluated the comments received on the San Ramon City Center Project. The responses to the comments and other documents, which are included in this document, together with the Mitigation Monitoring and Reporting Program, comprise the Final Subsequent Environmental Impact Report (Final SEIR) for use by San Ramon City Council in their review.

This document is organized into these sections:

- **Section 1** - Introduction.
- **Section 2** - Responses to Written Comments on the Draft Subsequent EIR (DSEIR): Provides a list of the agencies, organizations, and individuals that commented on the DSEIR. Copies of all of the letters received regarding the DSEIR and responses thereto are included in this section.
- **Section 3** - Responses to September 4, 2007 Planning Commission Hearing on the DSEIR: Includes the transcript of the hearing and responses thereto.
- **Section 4** - Errata: Includes an addendum listing refinements and clarifications on the DSEIR, which have been incorporated.

Due to its length, the text of the DSEIR is not included with these written responses; however, it is included by reference in this Final EIR.
