

# Auburn Parks, Arts & Recreation KidsDay 2023 Food Vendor Application Deadline: May 22, 2023\*\*\*\*



**Date:** Friday, June 23, 2023

**Time:** 11:00am – 4:00pm

**Location:** Les Gove Park, 910 9th St SE

**Event profile:** An event specifically designed for Auburn's youngest citizens! The event features live entertainment, inflatable rides, mini golf, kids' art activities, a food court, numerous vendors and much more!

**Anticipated event attendance:** 13,000+

## **Selection Criteria and Booth Information:**

1. Food booths are uncovered 12' x 12' space. Vendors must supply their own materials (canopies, tables, electrical cords, signs, etc.) and are responsible for all set-up and take-down.
2. Food trucks are accepted on a space available basis. Food trucks are charged for one booth space. Please include size of truck, location of vent (if applicable) and any other helpful information on the application form.
3. We do not allow duplication of major food items at this event.
4. A \$50 non-refundable deposit is due upon submitting the application. Your application will not be reviewed without the \$50 deposit. Full payment is due one month prior to the event date.
5. The fee is \$200 per booth (inclusive of deposit). The fee for a non-profit organization is \$40 per booth. Food vendors may reserve up to two booths. The deposit (or complete payment) must accompany the application. Unapproved applications and payments/deposits will be returned. After the application deadline, we may accept late vendors on a space-available basis. The late fee is \$240 and \$48 for non-profit organizations.
6. Accepted food vendors must provide proof of insurance, by May 31, 2023 for two million (\$2,000,000) dollars naming the City of Auburn as additional insured.
7. Electricity is available on a limited basis (see reverse for fee structure). Payment must accompany application. If you're bringing your own source of temporary power, you're required to obtain and L&I Permit and schedule your inspection. Please contact L&I directly (a minimum of 10 working days prior to the event) a 206-835-1000.
8. Depending on menu items, vendors may be required to apply for a temporary food service permit or plan review. Please contact Seattle-King County Department of Public Health for information.
9. Washington State law requires food vendors selling beverages in single-use aluminum, glass or plastic bottles or cans to provide recycling containers.
10. The City of Auburn does not require a percentage of sales. Vendors keep all of their revenue.
11. No refunds after the application deadline of May 22, 2023. Deposit is non-refundable.
12. Complete event information will be e-mailed the week of June 5, 2023.
13. Rules, regulations and event details are subject to change based on State of Washington COVID-19 related guidelines.

*RELEASE – The Applicant is fully aware that there are special dangers and risks inherent in this activity, including, but not limited to, serious physical injury, death or other harmful consequences, that may arise directly or indirectly from participation in this activity and harm the Applicant listed above or its individual members. Being informed of these risks and in consideration of being allowed to participate, we assume all risk of injury, damage, and harm to any member arising from participation. The Applicant agrees to indemnify, defend, and hold harmless the City, its officials, employees, volunteers, and agents from all causes of action, claims, and fees arising from its participation, except those arising from the City's sole negligence, and waive any right of recovery against the City for personal injury, death or other consequences occurring from participation in this activity. I agree that I have authority to enter into this agreement for the Applicant.
