

**NOTICE OF REGISTRATION FOR THE
ELECTION TO BE HELD ON TUESDAY, NOVEMBER 8, 2022
CITY OF NORTHVILLE, MICHIGAN**

TO THE QUALIFIED ELECTORS OF THE CITY OF NORTHVILLE, please take notice that any qualified elector of the City of Northville who is not already registered, may register to vote at the office of the City Clerk; the office of the Wayne or Oakland County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at michigan.gov/vote and mailed to the City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, October 24, 2022**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the City of Northville Clerk's office, located at 215 W. Main Street, Northville, MI 48167 at the following times:

- Regular business hours: Monday through Friday from 8:00 a.m. to 4:30 p.m.
- Saturday, November 5th from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, November 8th from 7:00 a.m. to 8:00 p.m.

The election will be conducted in all voting precincts in the City of Northville for the purpose of electing candidates for the following offices:

State:	Governor and Lieutenant Governor, Secretary of State, Attorney General
Congressional:	Representative in Congress
Legislative:	State Senator, Representative in State Legislature
State Boards:	Member of the State Board of Education, Regent of the University of Michigan, Trustee of Michigan State University, Governor of Wayne State University
County:	County Executive (Pct 1 only), Sheriff – partial term (Pct. 1 only), County Commissioner
Judicial:	Justice of Supreme Court, Judge of Court of Appeals, Judge of Circuit Court, Judge of Probate Court, Judge of 35 th District Court
Community College:	Schoolcraft College Board of Trustees Member
Local School District:	Northville Public Schools Board Member
District Library:	Northville District Library Board Member
