NOTICE IS HEREBY GIVEN: Sealed proposals will be received at City Hall, located at 5290 Grand Meadow Drive, Asbury, IA 52002, until 10:00 AM July 6, 2022 for the City of Asbury Hidden Meadows Overlay. All bids will be publicly opened and read aloud at that time.

NOTICE IS HEREBY GIVEN: The City Council of the CITY OF ASBURY will conduct a public hearing on the plans, specifications, form of contract, and estimate of cost for the construction of the above-described improvements on June 28, 2022 at 7:00 PM at Asbury City Hall, Asbury, Iowa. Any interested person may appear and file objections to the proposed plans, specifications or contract. After hearing objections, the CITY OF ASBURY, shall by resolution, enter its decision on the plans, specifications and contract.

NOTICE IS HEREBY GIVEN: On July 12, 2022 at 7:00 p.m. at Asbury City Hall, Asbury, Iowa, the City Council of the CITY shall consider the construction bids received and either award a contract, reject al bids, or adjourn action thereon to a subsequent meeting of the City Council.

The work for which bids are asked includes the following: Asphalt overlay, asphalt milling, full-depth asphalt patching, and related restoration on Hidden Meadows Drive and Budd Road in Asbury, Iowa.

The BIDDING DOCUMENTS may be examined at the offices of MSA Professional Services, Inc., Dubuque, Iowa and the City Of Asbury; A plan holders list will be updated interactively on our web address at <http://www.msa-ps.com> under Bids.

Effective July 1, 2010, per Senate File 2389 Iowa Code Chapter 26.3, paper copies of the BIDDING DOCUMENTS may be obtained at the office of MSA Professional Services, 400 Ice Harbor Drive, Ste 110, Dubuque, IA 52001 upon receipt of a refundable deposit of \$75.00 for a half size (11" x 17" sets of plans. Any plan holder upon returning the BIDDING DOCUMENTS within 14 days after award of the project and in good condition will be refunded their deposit. Mailing costs for paper copies will be paid for by the Requestor.

Each BIDDER shall accompany its bid with a bid security as security that the successful BIDDER will enter into a contract for the work bid upon and will furnish after the award of CONTRACT a corporate surety bond, acceptable to the OWNER, for the faithful performance of the CONTRACT, in an amount equal to 5 percent of the amount of the CONTRACT. The bid security

1 shall be in an amount fixed by the OWNER and shall be in the form of a cashier's check, or
2 certified check drawn on a state chartered or federally chartered bank, or a certified share draft
3 drawn on a state-chartered or federally chartered credit union. The Bid Bond shall contain no
4 exceptions.

5
6 By virtue of Statutory authority, a preference will be given to products and provisions grown and
7 coal produced within the State of Iowa and to Iowa Domestic Labor, to the extent lawfully required
8 under Iowa statutes.

9
10 OWNER is designated a Tax Exempt Entity. As such, CONTRACTOR, and any subcontractors,
11 under this contract, shall be provided a Tax Exempt Certificate and authorization letter from the
12 OWNER. Tax Exempt certificate and authorization letter shall be used by CONTRACTOR to
13 secure building materials or equipment intended for completion of this project without payment of
14 sales tax. CONTRACTOR is not mandated to complete Iowa Department of Revenue Form 35002
15 – Iowa Contractor's Statement upon execution of agreement. CONTRACTOR agrees to this
16 method of sales tax exemption and it shall not be modified during the course of construction.

17
18 BIDDER shall satisfy themselves of the accuracy of the estimated quantities in the BID schedule
19 by examination of the site and review of the contract documents; including ADDENDA. After
20 BIDS have been submitted, the BIDDER shall not assert that there was a misunderstanding
21 concerning the quantities of WORK or nature of the WORK to be done.

22
23 The successful BIDDER shall be required to furnish a performance BOND and a payment BOND,
24 each in the amount of 100 percent of the CONTRACT PRICE, with a corporate surety approved
25 by the OWNER, within ten (10) calendar days of the date when the NOTICE OF AWARD is
26 delivered to the BIDDER. The NOTICE OF AWARD shall be accompanied by the necessary
27 AGREEMENT and BOND forms. In case of failure of the BIDDER to execute the
28 AGREEMENT, the OWNER may at his option consider the BIDDER in default, in which case
29 the BID BOND shall become property of the OWNER.

30
31 BIDDERS must indicate on the BID form the proposed equipment and subcontractors who will be
32 performing the major portions of the work.

33
34 No BID submitted by any BIDDER which contains a condition or qualification shall be recognized
35 or accepted by the OWNER and any letter or communication accompanying the BID which
36 contains a condition or qualification upon the BID which has the effect of qualifying or modifying
37 any provision of the contract documents in any manner will be construed as a qualifying BID and
38 will be rejected by the OWNER as non responsive.

39
40 No bidder may withdraw his bid within 60 days after the actual date of the opening thereof

41
42 All work will commence following the issuance of a written notice to proceed. The work will be
43 substantially completed on or before September 16, 2022 and ready for final payment in
44 accordance with Paragraph 14.07 of the General Conditions on or before September 30, 2022.

46 OWNER reserves the right to waive any informalities or to reject any or all bids.
