BYLAW NUMBER 21-G

A Bylaw to amend the Water and Sewer Customer Service Regulations Bylaw (Bylaw # 21) to replace section 51 and 54 with new wording.

BE IT ENACTED by the Council of the Town of Stratford as follows:

The Stratford Water and Sewer Customer Service Regulations Bylaw, Bylaw # 21, shall be amended as follows:

1) Replace Section 51 and 54, Meter Services and Installation and Removal of Meters with new Section 51 and 54 as follows:

51. Metered Services

Except when water is used for construction purposes from a hydrant, under the supervision of the utility, and except as otherwise provided in this bylaw, all service other than that designated for fire protection, shall be metered.

54. Installation and Removal of Meters

(a) Water meters shall be installed and removed only by employees of the utility and its representatives, and no other person shall install, alter, change or remove a meter.

(b) Water meter connections shall be completed in accordance with the manufacturer's recommendations, including provisions for testing, at the cost of the customer, unless covered through a program delivered by the Town.

(c) A meter bypass shall be installed by the customer where flow cannot be interrupted to replace or test the meter. Where a meter bypass exists, a seal shall be placed on the bypass valve by the utility. The bypass valve shall be of a type designed to have a seal applied.

(d) Any customer who refuses to cooperate to allow the installation of a meter on his/her property will be subject to a non-refundable fee, in accordance with the charge set forth in Schedule A to this bylaw. A minimum of three (3) attempts to coordinate the

installation will be made, including a final written notice. This fee will appear on the first bill following delivery of the final notice and will continue to be charged until such time as a meter is installed at the property.

- 2) Replace Schedule A with the revised attached Schedule A.
- 3) The effective date of this bylaw is April 11, 2018.


