

ANNUAL WALK ON BLUE MOUNTAIN

ACKNOWLEDGMENT OF RESPONSIBILITY, EXPRESS ASSUMPTION OF RISK AND RELEASE OF LIABILITY

I understand that during my participation in this event, I and those in my care may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in and cannot be eliminated from this community activity. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and death, and that the organizers of this event have not tried to contradict or minimize my understanding of these risks. I understand that injuries and damages can occur by natural causes or activities of other persons, animals, and those assisting with this event.

I confirm my understanding that:

I may not begin the walk prior to 8:00 a.m. and no later than 10:45 a.m. I must start back down no later than 12:30 p.m. I am expected to be back to the staging area no later than 2:00 p.m.

Friendly pets are allowed but must remain on a leash and waste must be picked up. Event organizers retain the right to dismiss participants with pets unsuitable for the event.

I must remain in designated areas and stay on the road while traveling on the mountain. Once inside the gates, the entire private property is designated **non-smoking**.

This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.

To the fullest extent allowed by law, and in order to participate in this event, I agree to **INDEMNIFY AND HOLD HARMLESS, RELEASE, and FOREVER DISCHARGE** Friends of Blue Mountain, the property owners, the City of Grand Terrace, The Foundation of Grand Terrace, Sierra Club, Azure Hills Church and any other authorized event sponsors or safety personnel including any officers, directors, employees, agents and leaders of the above ("Blue Mountain parties") from any and all claims, demands, injuries, damages, causes of action or obligations whatsoever, including attorneys' fees ("claims"), which may arise out of or in connection with this event, including without limitation the negligence (but not the gross negligence) of the Blue Mountain parties. I hereby agree to **WAIVE** and relinquish any and all of the above claims or rights I may have against the Blue Mountain parties in connection with this event. I understand that this document may be pled as a complete bar and defense to any action or other proceedings instituted or filed by me against the Blue Mountain parties on account of any matter contained herein.

I have read this document in its entirety and I freely and voluntarily **ASSUME ALL RISKS** of any and all of the above claims, and notwithstanding such risks, I agree to participate in this event. _____
