3. Proof of Posting: The agenda was posted in the upper and lower levels of the Amundson Community Center, Cambridge Post Office, Hometown Bank and the Village Website.

4. New Business:

- a. Presentation by Todd Schultz and Mike Herl on proposed development: They are proposing purchasing 114 Acres adjacent to the Village of Cambridge. The land would be purchased from the Hinchleys and is currently slated to be part of the solar project. 47 acres would be Highway Business with uses allowed per our ordinance: commercial, retail, restaurants. 25 acres would be multi family with various levels from entry level to more luxurious units, with parks, green space, walking trails. 42 acres would be single family homes. Right now there is a lot of interest in starter homes in Dane County \$250,000-\$300,000. Looking for substantial activity within 2 years, with a timeline of 5-10 for everything. Construction costs are beginning to drop. This would increase the footprint of the Village by 15%. The land would need to be annexed into the Village and a pay go TIF would be requested for utilities and infrastructure. The TIF would include the Business Highway and Multi-family portions, as well as the land that is currently owned. The current land would be needed for ingress, it would also connect to Rodney Road. At this point the DOT has directed that this would be a signaled intersection.

Rose made the same motion for the Energy Subcommittee, seconded by McNally. Motion carried on a 5-0 vote.
