

RESOLUTION NO. R-45-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PULLMAN, WHITMAN COUNTY, WASHINGTON, RELATING TO CHAPTER 16.39 OF THE PULLMAN CITY CODE, ENVIRONMENTAL (SEPA) PROCEDURES, AND AMENDING PULLMAN CITY RESOLUTION NO. R-100-99 (1999) AND OTHER MATTERS PROPERLY RELATED THERETO.

WHEREAS, Section 16.39.200 of the Pullman City Code provides that the City shall require fees for its activities as set forth in resolutions adopted by the City Council; and

WHEREAS, pursuant to Resolution No. R-100-99, a copy of which is attached hereto and by this reference incorporated herein, the City approved a deposit fee for the filing of an environmental checklist; and

WHEREAS, the City now wishes to eliminate such deposit fee; now therefore

IT IS HEREBY RESOLVED by the City Council of the City of Pullman that Exhibit "A" to Resolution No. R-100-99 is amended as follows (deleted language ~~stricken~~, added language double-underlined):


