Notice of Water Rate Adjustment**

On April 4, 2015, the Rohnert Park City Council adopted a new water rate structure effective July 1, 2015. In adopting the new water rate structure, the City Council also adopted procedures for automatically adjusting the water rates each January from 2016 through 2020 to reflect changes in costs of wholesale water purchases from the Sonoma County Water Agency (SCWA), as well as changes in general inflation. Both of these adjustments were determined to be necessary in order to maintain water rates at a level that reflects the cost of providing water service, as well as to help ensure that the City's water utility would be able to meet service and financial obligations. Per Government Code 53756, notice is hereby given that an adjustment will take place, effective January 1, 2018. As shown at the bottom of Rate Adjustment Chart, the increase in a typical single family water bill resulting from the SCWA adjustment will be about \$0.46 and the CPI adjustment will be about \$1.19 per month.
