

# THE CORPORATION OF THE VILLAGE OF CASSELMAN

## BY-LAW NUMBER: 2016-035

BEING A BY-LAW TO AMEND THE SCHEDULE I OF BY-LAW 2006-182 REGULATING THE TRAFFIC AND PARKING ON THE HIGHWAYS WITHIN THE VILLAGE OF CASSELMAN AS AMENDED.

1. That By-law number 2006-182 is hereby amended by deleting Schedule "I" in its entirety and replaced by a new Schedule "I" outlined in Schedule "A" hereto attached and forming part of this by-law;
