

OFFICIAL NOTICE TO BIDDERS

BEVERLY LANE WATER MAIN EXTENSION VILLAGE OF PLEASANT PRAIRIE KENOSHA COUNTY, WISCONSIN

OWNER: The Village of Pleasant Prairie hereby gives notice that Bids will be received for the construction of the Beverly Lane Water Main Extension project.

The Project consists of one prime Contract and generally consists of the following: water main extension, water service, sanitary sewer lateral, storm sewer lateral, site restoration, and construction staking. Approximate quantities include: 198 LF of water main; 2 EA 1-1/2 water services; 1 EA hydrant assembly; 27 LF sanitary sewer lateral; and 41 LF sump pump lateral.

All Contractors shall comply with the "Contractor Qualification Ordinance of the Village of Pleasant Prairie" requiring pre-qualification of Contractors prior to performing work on this Contract. All Contractor pre-qualifications must be complete and submitted 5 days prior to bid opening date/time. Approved pre-qualifications will be posted prior to bid opening. All Sub-contractors utilized for this Contract must be identified in the bid documents under "LIST OF SUBCONTRACTORS AND SUPPLIERS" and all Sub-contractors must be pre-qualified prior to award of this Contract. TIME AND PLACE OF BID OPENING: Sealed Bids will be received until **2:00 P.M., Local Time, on Thursday, July 14th, 2022**, in the office of the Village Engineer, 9915 39th, Pleasant Prairie, Wisconsin, 53158. After the official Bid closing time, the Bids will be publicly opened and read aloud.

BIDDING DOCUMENTS: The documents are on file for inspection at the Village Hall, 9915 39th Avenue, Pleasant Prairie, Wisconsin, 53158. All submitted Bidding Documents shall be original copies obtained directly from QuestCDN. Paper copies of the Bid Documents will not be made available.

LEGAL PROVISIONS: The Contract letting shall be subject to the provisions of Sections 61.54, 61.55, 66.0901, and 66.0903 of the Wisconsin Statutes.

BID SECURITY: Bid Security in the amount of not less than 5% nor more than 10% of the Bid shall accompany each Bid in accordance with the Instructions to Bidders. Acceptable Bid Security shall be Bid Bond, Certified Check, Cashier's Check, or Money Order.

CONTRACT SECURITY: The Bidder to whom the Contract is awarded shall furnish a Performance Bond and Payment Bond each in the amount equal to the Contract Price.

BID REJECTION / ACCEPTANCE: Owner reserves the right to reject any and all Bids, waive informalities in bidding or accept the Bid or Bids, which best serve the interest of Owner.

BID WITHDRAWAL: No Bid shall be withdrawn for a period of 40 days after the opening of the Bids without the consent of Owner.
