

## OFFICIAL NOTICE TO BIDDERS

### CHATEAU EAU PLAINES SOUTH WATER MAIN AND PAVING IMPROVEMENTS VILLAGE OF PLEASANT PRAIRIE KENOSHA COUNTY, WISCONSIN

OWNER: The Village of Pleasant Prairie hereby gives notice that Bids will be received for the construction of the Chateau Eau Plaines South Water Main and Paving Improvements. For this project, the Village of Pleasant Prairie will **ONLY** be receiving and accepting bids via the online electronic bid service through QuestCDN.com.

The Project consists of one prime Contract and generally consists of the following: water main and appurtenance abandonments and removals, water main relay, gate valves, hydrant assemblies, water service relays, manhole rehabilitations, pulverize asphaltic pavement, base aggregate dense, asphaltic concrete pavement, erosion control, traffic control, and construction staking. Approximate quantities include: 5,300 LF of water main abandonment and filled with grout; 1,200 LF of 8" water main relay; 375 LF of 12" water main relay; 18 gate valves; 20 hydrant assemblies; 780 LF of 1.5" water service relay; 31 manhole rehabilitations; 17,500 SY of pulverize asphaltic pavement; 2,750 Tons of base aggregate dense; and 5,800 Tons of asphaltic concrete pavement.

All Contractors shall comply with the "Contractor Qualification Ordinance of the Village of Pleasant Prairie" requiring pre-qualification of Contractors prior to performing work on this Contract. All Contractor pre-qualifications must be complete and submitted 5 days prior to bid opening date/time. Approved pre-qualifications will be posted prior to bid opening. All Sub-contractors utilized for this Contract must be identified in the bid documents under "LIST OF SUBCONTRACTORS AND SUPPLIERS" and all Sub-contractors must be pre-qualified prior to award of this Contract. **TIME AND PLACE OF BID OPENING:** Electronic bids will be accepted until **2:00 P.M., Local Time, on Wednesday, April 20, 2022**. After the official Bid closing time, the bids will be opened, reviewed and displayed (if accepted). To access the electronic bid form, download the project documents and click the online bidding button at the top of advertisement. The electronic bid form will be available for completion beginning **Tuesday, April 12, 2022**.

**BIDDING DOCUMENTS:** Contract Documents and the Construction Plans may be obtained **ONLY** from QuestCDN.com. All submitted Bidding Documents shall be original copies obtained directly from QuestCDN. Paper copies of the Bid Documents will not be made available.

LEGAL PROVISIONS: The Contract letting shall be subject to the provisions of Sections 61.54, 61.55, 66.0901, and 66.0903 of the Wisconsin Statutes.

PROJECT FUNDING AND SPECIAL REQUIREMENTS: The project is being funded through the State of Wisconsin Department of Commerce Development Block Grant. The Contractor is required to comply with Federal law standards (Davis-Bacon) and Contracting and Labor Standards (including but not limited to EO 11246) specified in the Bidding Documents.

WAGE RATES: Contractor shall be required to pay not less than the Federal (Davis-Bacon) wage rates on the project. Copies of the wage rates are on file at the Village Hall and incorporated into the Contract Documents.

BID SECURITY: Bid Security in the amount of not less than 5% nor more than 10% of the Bid shall accompany each Bid in accordance with the Instructions to Bidders. Acceptable Bid Security shall be Bid Bond, Certified Check, Cashier's Check, or Money Order.

CONTRACT SECURITY: The Bidder to whom the Contract is awarded shall furnish a Performance Bond and Payment Bond each in the amount equal to the Contract Price.

BID REJECTION / ACCEPTANCE: Owner reserves the right to reject any and all Bids, waive informalities in bidding or accept the Bid or Bids, which best serve the interest of Owner.

BID WITHDRAWAL: No Bid shall be withdrawn for a period of 40 days after the opening of the Bids without the consent of Owner.
