## HEALTH INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's safe drinking water hotline at (800) 426-4791.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised

persons, such as those: with cancer undergoing chemotherapy, who have undergone organ transplants, individuals with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk of infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbial contaminants are available from the Environmental Protection Agency's safe drinking water hotline at (800) 426-4791.

## EDUCATIONAL INFORMATION



The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally occurring or can result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which provide the same protection for public health.

## DEFINITION OF TERMS

In this table, you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms, we've provided the following definitions:

<b>Level 1 Assessment</b>	A study of the water system to identify potential problems and determine, if possible, why total coliform bacteria have been found in our water system.	<b>MRDL</b>	Maximum Residual Disinfectant Level: the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
<b>Level 2 Assessment</b>	A very detailed study of the water system to identify potential problems and determine, if possible, why an E. coli MCL violation has occurred or why total coliform bacteria have been in our water system, or both, on multiple occasions.	<b>MRDLG</b>	Maximum Residual Disinfectant Level Goal: the level of a drinking water disinfectant below which there is no known or expected health risk. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
<b>AL</b>	Action Level: the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.	<b>mrem/year</b>	Millirems per Year: a measure of radiation absorbed by the body.
<b>MCL</b>	Maximum Contaminant Level: the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.	<b>n/a</b>	Not Applicable

## ADDITIONAL HEALTH INFORMATION

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Pleasant Prairie's water system, constructed after the use of lead piping was discontinued, does not contain any lead piping. Pleasant Prairie's Water Utility is responsible for providing high quality drinking water, but it cannot control the materials used in a home's private plumbing components. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing.

If you live in a home constructed prior to the 1940s, lead piping may have been used in your private water lateral or plumbing system, and you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline (800) 426-4791 or at [www.epa.gov](http://www.epa.gov). When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for

30 seconds to 2 minutes before using water for drinking or cooking.

In our continuing efforts to maintain a safe and dependable water supply, it may be necessary to make improvements in your water system. The costs of these improvements may be reflected in the rate structure. Rate adjustments may be necessary in order to address these improvements. Thank you for allowing us to continue providing your family with clean, quality water this year.

The Pleasant Prairie Water Utility makes it a priority to provide high quality water to the residents through daily operations and through quality assurance efforts. Protecting our natural water resources is something we can all take steps to do.
