If you wish to **participate** during the public comment portion of an agenda item, then you must:

When the Public Comment portion of a case you wish to speak on is open to the public, **you as an attendee must then click the “raise hand” button in order to indicate to the Chairperson or Secretary that you wish to speak.**

- If you are calling in to access the meeting you must dial *9 to raise your hand. *6 allows you to mute/unmute.
- After clicking “raise hand” listen for your name, phone number or other ID, given to you during login. Permissions to speak will be then granted to you.
- You cannot participate in public comment unless you are attending the virtual meeting through Zoom.

All microphones of public users will be muted, except as set forth above during the public comment portion.
