### Vendor Parking

*The Rambling River Center would like to request vendors to park in the lot located to across the street at the Boeckman Middle School after unloading your vehicles. This will allow for customers to park in the Schmitz- Maki parking lot and the street just south of the Arena.*

Vendors are required by MN State law to have a MN Tax ID Number. You can register for a MN Tax ID number at : [www.revenue.state.mn.us](http://www.revenue.state.mn.us) or call 651-282-5225. Exceptions are made if you do only 1 craft/flea market annually and make less than \$500. You must sign the attached form verifying this information and turn it with registration.
