2. Entry for Duette Headwaters is on Bradley Road – First Gate on the Right
3. Stay on designated Trails as per Preserve maps
4. No alcoholic beverages allowed in Preserve
5. For information on open fires – please ask Park Ranger
6. Please keep pets on leash
7. Do not feed wildlife
8. Please do not litter
9. Children under the age of 18 must be accompanied by an adult
