New Service Connections:

1. Must pay Water and Sewer SDF for each size water connection
2. Where applicable, use Iredell Water Meter Size to determine Sewer SDF
3. System Development Fees are not charged for FIRE LINES

Modification of Existing Service Connections:

1. When existing water and sewer connections are utilized for new development, no SDFs will apply.
2. When increasing water meter size for an existing service, or when demolishing an existing structure for new construction, a credit for existing service size SDFs will be applied toward new service size SDFs at that location only.
3. When adding service connections to a property, Water and Sewer SDFs will apply to each new water connection.
4. When separating existing legal taps (two houses conneted to same tap, e.g.), only tap fees apply.
